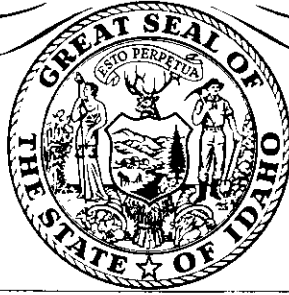

### CERTIFICATE OF INCORPORATION

One Thousand Nine Hundred **Sixty-one** and duly recorded on Film No. **114** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Gannett** in the County of **Blaine**

ARTICLES OF INCORPORATION  
OF  
HUTCHINSON-MILLS RODEO CORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of full age, and citizens of the United States of America, in order to form a corporation under the laws of the State of Idaho for the purposes hereinafter stated do hereby certify as follows:

I.

That the name of said corporation is Hutchinson-Mills Rodeo Corporation.

II.

That the principal office of said corporation is at Gannett, Blaine County, Idaho.

III.

That said corporation is formed for the following purposes:

A. Either alone, or in association with other persons, firms, associations or corporations, to establish, promote, provide, conduct, manage and control rodeos, wild west shows, parades, exhibitions and any and all other types of entertainment.

B. To sell admissions to any and all of the above named events, or to contract for fixed or ascertainable compensation therefor, and to do all things proper or advisable in promoting the financial welfare of said corporation.

C. To own, lease, manage and conduct livestock operations of every kind.

D. To own, lease, rent, manage and operate farms and ranches.

E. To buy, own, rent, loan, borrow and sell all kinds of livestock and all kinds of real and personal property which may be useful in any of the foregoing operations.

F. To hire or employ servants, agents, employees and attorneys to accomplish any of the purposes of the corporation and to compensate them by wages, salaries, fees or bonuses and to

obtain insurance of every kind to protect the financial interests of the corporation and said servants, agents, employees and attorneys.

G. To buy, sell, mortgage, convey, or in any manner acquire, own and dispose of all kinds of real and personal property necessary or useful in accomplishing any of the aforesaid purposes; and to do each and every act and thing requisite, necessary or proper in accomplishing any of the aforesaid purposes.

IV.

The corporation is to have perpetual existence.

V.

The total authorized number of shares in said corporation is 250 shares of the par value of \$100.00 each.

VI.


