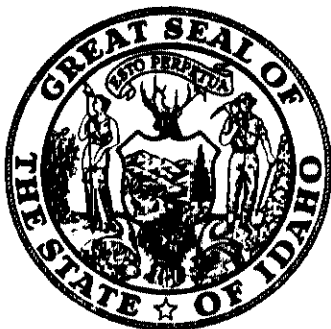
CERTIFICATE OF INCORPORATION OF

That we, the undersigned, being natural citizens of the United States and of full age and majority, have this day signed and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I.

The name of this corporation shall be J & C SHOSHONE FOOD MART, INC.


