I, the undersigned, being a natural person of full age, and a citizen of the United States or of its territories or possessions, have this day executed these Articles for the purpose of forming a private corporation under the laws of the State of Idaho and to that end hereby adopt these Articles of Incorporation as follows:

ARTICLE ONE NAME OF CORPORATION

The name of the corporation is AUTO SHOP, INC.

ARTICLE TWO PURPOSE OF INCORPORATION

ARTICLE FIVE STOCK

The aggregate number of shares the corporation is authorized to issue shall be 50,000, all of which shall be common voting stock.

ARTICLE SIX BOARD OF DIRECTORS & BY-LAWS

The corporation shall have the power to establish a Board of Directors and adopt appropriate By-Laws. The duties of the Board of Directors and its officers shall be established by the By-Laws of the corporation.
