A NONPROFIT CORPORATION**


To the Secretary of State of Idaho:

Pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code, the undersigned non-profit corporation has elected to dissolve.

2. The Organization ID / Filing Number for the Corporation is: C158316.
3. The date the dissolution was authorized is: DECEMBER 20, 2005

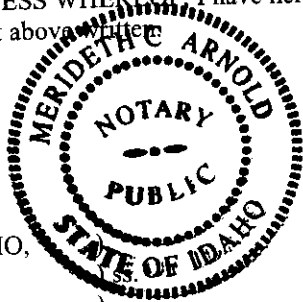

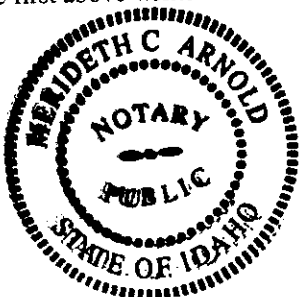
