





ARTICLES OF INCORPORATION
OF
BELLAMY, LONG & COMPANY, P.A.

The undersigned incorporators desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is BELLAMY, LONG & COMPANY, P.A.

ARTICLE II

Purposes

The purposes for which the corporation are formed are to engage in the practice of architecture, architectural planning and interior designing; to consult, plan, design, administrate, investigate, reconnoiter, and research the development of buildings, and structures; to engage generally in the business of an architecture corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, to transact any lawful business related thereto; to engage in such other


