- 7. Additional contributions, if any, agreed to be made by each limited partner and the times at which or events on the happening of which they will be made will be based upon written agreement of all the limited partners.
- 8. The time when the contribution of each limited partner is to be returned is as follows:

Payment in the first quarter upon which profit is made.

- 9. The shares of the profits: see Article XII.
- 10. Each limited partner may substitute an assignee as a contributor and substitute limited partner in his place.
 - 11. The partners may admit additional limited partners.
- 12. Division of profits: the limited partners will receive 100% of all distributable profits until they have received 200% of their original investment. After that date, limited partners percentage of distributable cash will be reduced to 80% for a
