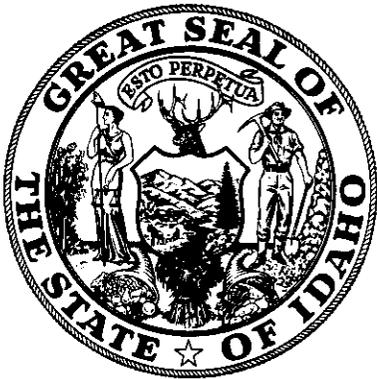
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF
CLARK EQUINE CLINIC, P.A.

The undersigned incorporator who is a duly licensed Doctor of Veterinary Medicine holding a license issued under authority of Chapter 13, Title 30 of the Idaho Business Corporation Act, and currently practicing the profession of Veterinary Medicine in the State of Idaho, desires to form a professional corporation for the purpose to rendering veterinary services and does hereby adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME: The name of the corporation shall be CLARK EQUINE CLINIC, P.A.

ARTICLE II

PURPOSE AND POWERS: The purpose for which the corporation is formed is to engage in the general practice of Veterinary Medicine and all services ancillary thereto. In connection with the above mentioned purpose, the Corporation shall in addition have the power to own real and personal property necessary or appropriate to rendering the above designed professional services. And, may invest its' funds in real estate, mortgage, stocks, and bonds and any other necessary investments and to do all other acts to extend permitted under Chapter 13, Title 30 of Idaho Business Corporation Act.

ARTICLE III

PRINCIPLE OFFICE: The principle office of the corporation in the State of Idaho is Star Route Box 19, Albion, Idaho. 83311.

ARTICLE IV

INCORPORATOR: The name and post office address of the incorporator is:

The name of the initial registered agent at the principle office of the corporation shall be Alan G. Clark.

The above designated individual is licensed to render professional services as a Doctor of Veterinary Medicine as required under Chapter 13 of Title 30, Idaho Business Corporation Act.

ARTICLE V

INITIAL OFFICER AND DIRECTORS: The corporation shall be governed by a board consisting of no less than one (1) and no more than three (3) directors. Directors shall be stockholders in the Corporation and elected by the stockholders. The number of directors constituting the initial Board of Directors is one (1), and the name and post office address of the person who shall serve as director until his successor(s) are elected and qualify are:

No person may be an officer, director or shareholder who is not an individual duly licensed to render professional services as a Doctor of Veterinary Medicine except the Secretary/Treasurer who may serve in that capacity without having qualified to practice under Chapter 13 of Title 30 Idaho Business Corporation Act.

ARTICLE VI

CAPITALIZATION: The aggregate number of shares of stock that the corporation is authorized to issue is 25,000 shares, which shares shall be common stock having a par value of \$1.00 per share. Stock shall be issued only to persons who are licensed to practice Veterinary Medicine in the State of Idaho.

ARTICLE VII

INITIAL CAPITAL: The corporation shall not begin business until the sum of \$1,000.00 has been received for issuance of shares.

ARTICLE VIII

SHAREHOLDERS AND OFFICERS: The original shareholder is Alan G. Clark. The officer is:
