The undersigned, acting as incorporators of a corporation under the non Profit Corporation Act of the State of IDAH, at the following articles of incorporation.

ARTICLE I

The name of the corporation is Jefferson Academy Inc.

ARTICLE II

The corporation's duration shall be perpetual.

ARTICLE III

The purposes for which the Corporation is organized are to engage in any activity permitted under the laws of the united states (in which a non profit corporation in this state is permitted to engage) be a private educational institution teaching grades k-12; through the promotion of educational activities; conduct any and all activities which result in educational benefit to recipients or is associated with providing educational benefits designated by the corporation.

Upon dissolution no pecuniary profit or financial gain shall inure to the directors or officers or any member except as permitted under the Idaho Non profit Corporation Law then in effect.

In particular, upon dissolution of the corporation, the assets of the Corporation shall be disposed of pursuant to IDAHO CODE SECTION 30-3-17 (g) or its successor statute then in effect.

ARTICLE IV

The qualifications for members and the manner of their admission and continued activity in the corporation and school shall be regulated by the by-laws, policies and procedures.

ARTICLE V
