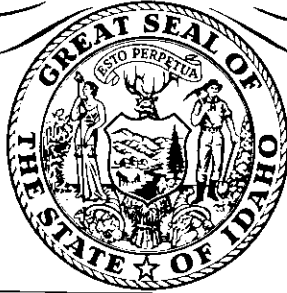

CERTIFICATE OF INCORPORATION

One Thousand Nine Hundred **Sixty-four** and duly recorded on Film No. **127** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at

ARTICLES OF INCORPORATION
OF
SHAKE PACKING, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all full age citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

I.

That the corporate name of this corporation shall be "SHAKE PACKING, INC."

II.

That the purposes and objects for which said corporation are formed are as follows:

(a) To engage in the business of packing, storing and shipping of fresh fruits and vegetables; the holding of insecticides, fertilizers and general farm and orchard supplies; together with the buying and selling of fruits, vegetables and farm supplies, together with any and all businesses or transactions conveniently incidental to and in anywise connected with the purposes set forth in this paragraph.

(b) To acquire, buy, own, hold, sell, exchange, let or lease personal property and real estate within the State of Idaho, or outside the State of Idaho, and to lend money for profit, and to make, hold, and realize upon any property pledged or hypothecated for the payment thereof.

(c) To borrow money for the purposes of this corporation, to issue bonds, notes and debentures and other evidences of indebtedness therefor, and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of the corporation may be so pledged, mortgaged or hypothecated.

(d) To build any or all buildings, structures, warehouses and stores necessary or convenient for the conduct of business of said corporation, or to acquire the same by purchase, lease or otherwise.

(e) To purchase, lease, or otherwise acquire, in whole or in part, the business, goodwill, rights, franchises and property of every kind, and to take over the whole or any part of the assets or liabilities of any per-

1 son, firm, association or corporation engaged in or authorized to be conduct-
2 ed by this corporation, or owning property necessary or suitable for its pur-
3 poses and to pay for the same in cash, in the stock or bonds of this corpora-
4 tion, or otherwise; to hold or in any manner dispose of the whole or any
5 part of the business property so acquired, and to exercise all the powers
6 necessary or incidental to the conduct of such business.

7 (f) To enter into any contract, co-operative agreement or profit
8 sharing plan with its officers or employees that the corporation may deem
9 advantageous or expedient, or otherwise to reward or pay such persons for
10 their services as the directors may deem fit.

11 (g) To purchase, or otherwise acquire, own, hold, mortgage, pledge,
12 sell, assign, transfer or otherwise dispose of shares of capital stock of
13 this corporation or evidences of indebtedness of any kind or nature created
14 by any corporation or corporations, wherever organized, whether public or
15 private, including the right to participate in the forming of any new
16 corporation that in anywise affects or is related to the major purposes of
17 this corporation, including the purchase of stock of any other corporation.

18 (h) To exercise generally the powers customarily exercised by busi-
19 ness corporations, and particularly the powers provided by the laws of the
20 State of Idaho, referring especially to Section 30-114 Idaho Code, in any
21 State in the United States and throughout the world.

22 (i) To carry on any other business, or to do anything in connection
23 with the objects and purposes above mentioned that may be necessary or
24 proper to accomplish successfully or promote the said objects and purposes.
25 The foregoing clauses, by reason of the specific enumeration of powers,
26 shall not be held to restrict the powers of the corporation to do any of the
27 things within the purview of its general purposes.

28 III.

29 This corporation shall have perpetual existence.

30 IV.

31 The location and post office address of the registered office in this
32 State and principal place of business shall be Payette, Payette County,

1 Idaho.

2 V.

3 The authorized capital stock of this corporation shall be TWO HUNDRED
4 FIFTY THOUSAND and NO/100 (\$250,000.00) DOLLARS, divided into 2500 shares
5 of common capital stock at the par value of \$100.00 per share, each share of
6 which stock shall be entitled to one vote on all matters, and no subsequent
7 issue of any stock shall be entitled to any voting privileges, and no pre-
8 ference or restrictions are granted to or imposed upon this first issue
9 of 2500 shares of common capital stock, except that said stock shall be non-
10 assessable.

11 VI.

12 That the corporate powers of said corporation shall be vested in a
13 board of directors, five in number, which shall be elected and chosen as
14 set forth in the By-Laws of this corporation.

15 VII.

16 That the corporate stock of said corporation, at the date of said
17 incorporation is subscribed as follows:

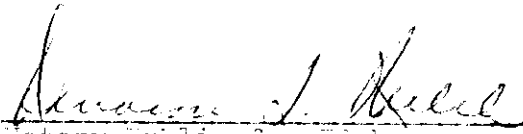
