FIRST: That the Board of Directors of Idaho Hereford Ranch, Inc., and Idaho Corporation, having its principal place of business at Gooding, Idaho, at a meeting duly called and held on the 6th day of March, 1979, adoped the following resolutions:

RESOLVED:

1. That it is advisable to amend the Article I of the Articles of Incorporation of this Corporation by striking Article I of the Articles of Incorporation and inserting in lieu of the Following Amenament:

ARTICLE I.

That the name of the corporation shall be FIELDS INVESTMENT CORPORATION

2. That it is advisable to amend Article II of the Articles of Incorporation of this corporation by striking Article II of the Articles of Incorporation and inserting in lieu thereof the following amendment.

ARTICLE II.

Section 1. The purposes for which this corporation is organized are as follows:

- A. To conduct a general farming and livestock business and in that regard: To acquire and own, operate, improve and develop farms, agricultural lands, grazing lands and rights therein; to lease and operate farms, agricultural lands, grazing lands and rights therein and to deal and trade in farms, agricultural lands, grazing lands, and rights therein; to deal and trade in and to own and manage livestock; and to deal and trade in livestock products and by-products.
- B. To buy, sell, handle, store, and otherwise acquire exchange any and all types, varieties and kinds of agricultural roducts, and to engage in the business of grading, sorting, preserving, processing and marketing thereof either at wholesale or retail.
- c. To operate and engage in all types of farm management services, including but not limited to, leasing agricultural property and collecting the rents therefrom; supervision of planting, growing, harvesting and marketing of crops; supervision and planning of construction and repair of buildings, irrigation and drainage facilities; and supervision of soil conservation programs and land leveling.

D. To conduct a general brokerage, agency and commission business for others in the purchase, sale and management of real estate for others and the negotiation of loans thereon; to purchase and sell for others personal property, stocks, bonds, and notes, and to negotiate loans thereon for others; to act as trustee in Deeds of Trust of Mortgages on real or personal property or evidences of value to secure them, and to act as agents for letting houses, lands, and the collection of rents and the payment of taxes.

E. To conduct its business and carry out the purposes set forth above in any state, territory, district or possession of the United States or in any foreign country, to the extent not forbidden by law.

Section 2. This corporation shall have all the powers specified in Section 30-114, Idaho Code or any other sections of Chapter 1, Title 30, Idaho Code, (Idaho Business Corporation Act), together with such other authority and powers conferred by law.

3. That a meeting of the stockholders of the Corporation, to take action upon the amendments advised as aforesaid, be in the same is hereby called to convene at the principal office of the corporation on the 7th day of March, 1979, at 10:00 a.m.

SECOND: That the meeting of Stockholders of the Corperation, called by the Board of Directors of the Corporation as aforesaid, was held on the ath day of March, 1979, pursuant to Waiver of Notice duly given and filed with the records of the meeting, and at said meeting the Stockholders, by the affirmative vote of two-thirds of the shares of stock outstanding and entitled to vote, duly adopted the Amendment of the Articles of Incorporation of the Corporation, advised by the Board of Directors as aforesaid.
