RE: Bank of Jackson Hole Trust – Use of the Word “Trust” in Company Name in Idaho

Dear Ms. Jaramillo:

The Idaho Department of Finance (Department) received an email from you on September 20, 2023, requesting an approval letter to file with the Idaho Secretary of State to register and use the business name “Bank of Jackson Hole Trust” (BJHT) in the state of Idaho. The email has been reviewed by Department staff. It is our understanding that BJHT is a Wyoming-chartered bank.

Idaho Code § 26-1202 of the Act provides that “no person may advertise or transact business in this state under a name or title that contains the word ‘bank,’ ‘banker,’ ‘bancorp,’ ‘savings bank,’ ‘trust company,’ or a word or words of similar import, unless the person has been granted a charter to engage in banking or trust business in this state by the director, or unless the director has granted the person a waiver from this prohibition as set forth in this section.”

However, Idaho Code § 26-1202(2) states that the “prohibition shall not apply to a ... national bank, federal thrift or federal savings bank, bank holding company or a state-chartered bank or trust company located in another state that has obtained all approvals that may be required under the law as a prerequisite to doing business in this state.” Since the statute does not apply to a Wyoming-chartered bank otherwise qualified, there is no need for the Director of the Department to grant a waiver to a Wyoming-chartered bank to use the word “trust” in its name in Idaho. Under these circumstances, the Department offers no objection to BJHT’s request to file a new or amended Foreign Registration Statement using the name “Bank of Jackson Hole Trust” in Idaho.

This no objection letter for the use of the word “trust” shall not be misconstrued as the Department granting any other authority to Bank of Jackson Hole Trust, as the entity must meet all applicable requirements of the Idaho Trust Institutions Act prior to acting as a fiduciary or otherwise engaging in trust business in Idaho.
