KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we DO HEREBY CERTIFY:

FIRST: That the name of this corporation is

TRI CITY INVESTORS, INC.

SECOND: That the purposes for which this corporation is formed are the following:

To acquire by lease, purchase, contract, concession, or otherwise, and to own, develop, explore, exploit, improve, operate, lease, enjoy, control, manage or otherwise turn to account, mortgage, grant, sell, exchange, convey, or otherwise dispose of either within or without the State of Idaho and in any country, domestic or foreign, any and all real estate, lands, options, concessions, grants, land patents, franchises, rights, privileges, easements, tenements, estates, hereditaments, interests, and properties of every description and nature whatsoever which the corporation may deem wise and proper in connection with the conduct of any business or businesses herein enumerated.

To purchase, lease or otherwise acquire, in whole or in part, the business, good will, rights, franchises, and property of every kind, and to undertake the whole or any part of the assets or liabilities of any person, firm, association, or corporation engaged in conducting or authorized to conduct any business similar to any business authorized to be conducted by this corporation; to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all the powers necessary to or incidental to the conduct of such business.

To promote and assist, financially or otherwise, corporations, firms, syndicates associations, individuals and others and to give any guaranty in connection therewith or otherwise for the payment of money or for the performance of any other undertaking or obligation.

In general, to have and exercise all powers, rights and privileges necessary and incidental to carrying out properly the objectives and objects above mentioned.

THIRD: That the principal office for the transaction of the business of this corporation shall be located in Pocatello, Bannock County, State of Idaho.

FOURTH: That the number of shares which may be issued by this corporation is FIVE THOUSAND and that the par value of each share is TEN DOLLARS. That the aggregate par value of all shares is FIFTY THOUSAND DOLLARS.
