Pursuant to § 30-1-61 of the Idaho Code for the State of Idaho, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation dated the 9th day of March, 1971.

The following amendments to the Articles of Incorporation were adopted by the shareholders of the corporation on the 30th day of March, 1989:

ARTICLE I
