ARTICLES OF INCORPORATION
OF
RONALD L. PIRNIE INSURANCE AGENCY, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is RONALD L. PIRNIE INSURANCE AGENCY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of the par value of \$100.00 per share, or a total of \$100,000.00 and all shares of the capital stock of this corporation shall be known as common stock, with each share of stock to be entitled to one vote.

FIFTH: The address of the initial registered office of the corporation is 811 7th Street So., Nampa, Idaho, 83651, and the

name of its initial registered agent at such address is Ronald Lee Pirnie.
