WILLIAM KOOP and EVERELL JEFFERSON, Chairman and Secretary, respectively, of the Board of Trustees of IMMANUEL EVANGELICAL LUTHERAN CHURCH OF BOISE, IDAHO, each being first duly sworn, on oath deposes and says: That a regular meeting of the members of said corporation was held at the church in Boise, Idaho on February 17th, 1957, at 12:00 noon; that there was a quorum attending said meeting; that the members in attendance voted unanimously in favor of amending Articles IV and V of the Articles of Incorporation and that Articles IV and V, as amended, shall read as follows, to-wit:

"Article IV

The term of existence of this corporation is to be perpetual.

Article V

The number of Trustees of this corporation shall be nine (9), but said number may be changed to not less than three (3) nor more than thirty-five (35) by vote of the membership in accordance with the church constitution."

That before said meeting a notice of meeting and of intention to vote on the proposition of amending Articles of Incorporation by changing Articles IV and V thereof was given by publication in the Idaho Daily Statesman, a daily newspaper published in the City of Boise, County of Ada, State of Idaho, wherein said meeting was held, in the issues of January 23rd and 30th and February 6th and 13th, 1957, and that in addition thereto a copy of said notice of meeting was posted on the bulletin board in the church of said corporation on January 23, 1957 and remained posted thereon

continuously between the dates January 23, 1957 and February 17th, 1957; that the proceedure of amending the Articles of Incorporation was in accordance with Sections 30-1103 and 30-1104 of Idaho Code and in accordance with the constitution and by-laws of said corporation.
