ARTICLES OF INCORPORATION
OF

SUPERIOR CONSTRUCTORS, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned,
have this day voluntarily associated ourselves together for the purposes of
forming a corporation under the laws of the State of Idaho, and to that end do
hereby adopt Articles of Incorporation and do hereby CERTIFY in writing as
follows:

I.

That the name of the corporation shall be SUPERIOR CONSTRUCTORS, INC.

II.

That the purposes for which said corporation is to be formed are
as follows:

To engage in the business of the construction and building of
dwelling houses, apartment houses, business buildings and any an all type of
other structures required for occupancy or adjacent or connected therewith
and this is to include and not be limited to homes, garages, out buildings,
barns, carports, commercial buildings and any an all type of construction in
this and allied fields, and to maintain a stock of goods, wares, and merchandise
of every kind and nature now or hereafter customarily sold or utilized in this
type of business or similar businesses or otherwise, and to generally deal in
any and all types of undertakings associated or allied with the repair, construct-
ion, or maintenance of any an all types of dwellings or buildings whether for
private or commercial use, or to contract for the performances of such purpose
or purposes.

To purchase, acquire, through the issuance of its own capital

1 stock or otherwise, own, hold, lease, either as lessor, lessee, sell, exchange,
2 subdivide, mortgage, deeds in trust, improve, develop, construct, maintain,
3 equip, operate and generally deal in any and all lands, improved and unimprov-
4 ed, and buildings of any kind, and the products and avails thereof, and any an
5 all other property of any and every kind or description, real, personal, and
6 mixed, wheresoever situated more particularly to manufacture, construct and
7 have manufactured or constructed any an all machinery necessary or required
8 for the production of the above named products.

10 To do all and everythin necessary, suitable, and proper for the
11 accomplishment of any of the purposes or the attainment of any of the objects
12 or the furtherance of any of the powers hereinbefore set forth, either alone
13 or in association with other corporations, firms, or individuals, and to do
14 every other act or acts, thing or things incidental or appurtenant to or growing
15 out of or connected with the aforesaid objects or purposes or any part or parts
16 thereof, provided the same be not inconsistent with the laws which this cor-
17 poration is organized, as fully as natural persons and to use and apply surplus
18 earnings or accumulative profits to the purchase or acquisition of its own
19 capital stock, from time to time, and to such extent and in such manner, and
20 upon such terms as its board of directors shall determine.

23 The purposes specified herein shall be construed both as purposes
24 and powers and shall be in no wise limited or restricted by reference to, or
25 inference from, the terms of any other clause in this or any other article, but
26 the purposes and powers specified in each of the clauses herein shall be re-
27 garded as independent purposes and powers, and the enumeration of specific
28 purposes and powers shall not be construed to limit or restrict in any manner
29 the meaning of general terms of the general powers of the corporation; nor
30 shall expression of one thing be deemed to exclude another, although it be of
31 like nature not expressed.

1 III.

2 That the principal office, and place of where the principal business
3 of said corporation is to be transacted is Carssow Building, Lewiston, County
4 of Nez Perce, State of Idaho.

5 IV.

6 That this corporation shall have perpetual existence.

7 V.

8 That the number of directors of said corporation shall be at
9 least three(3).

10 VI.

11 That the total authorized amount of capital stock of said cor-
12 poration shall be \$100,000.00 divided into 10,000 shares of common stock of
13 the par value of \$10.00 each.
