## ARTICLES OF INCORPORATION

That I, the undersigned, am duly licensed to render professional services as a physician, acting as incorporator of a Professional Service Corporation under the laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CORALYN J. ALEXANDER, M.D., P.A.

SECOND: The period of its duration is perpetual.
