ARTICLES OF INCORPORATION OF A NONPROFIT CORPORATION

ARTICLE FIVE DISSOLUTION

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code) or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE SIX PURPOSE

This nonprofit corporation is organized exclusively for charitable, educational, religious, and scientific purposes as defined under § 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code). Specifically, as a Christian organization, this corporation seeks to understand and alleviate common sufferings among uncommon peoples.

To further such purposes, this corporation shall have and may exercise all the powers conferred by the laws of the State of Idaho upon corporations formed under the laws pursuant to and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended; provided, however, that in all events and under all circumstances, and notwithstanding merger, consolidation, reorganization, termination, dissolution, or winding up of this corporation, voluntary or involuntary or by operation of law, the following provisions shall apply:

- (A) This corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.
- (B) No compensation or payment shall ever be paid or made to any member, officer, director, trustee, creator, or organizer of this corporation, or a substantial contributor to it, *except* as an allowance for actual expenditures or services actually made or rendered to or for this corporation; and neither the whole nor any portion of the assets or net earnings, current or accumulated of this corporation, shall ever be distributed to or divided among any such persons; provided, further, that neither the whole nor any part or portion of such assets or net earnings shall ever be used for, accrued to, or inure to the benefit of any member or private individual within the meaning of § 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code).

- (C) No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including publishing and distribution of statements) any political campaign on behalf of any candidate for public office.
- (D) This corporation may, from time to time, support or make contributions to or for the use of other organizations exempt at the time under § 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code).
