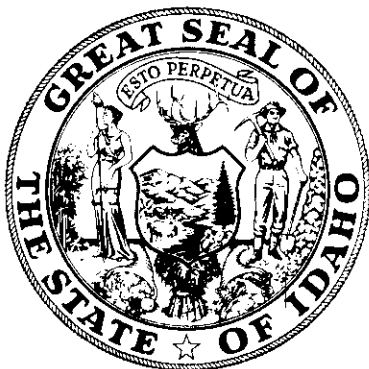

(A) The name of the corporation is SUNSHINE DEVELOPMENT, INC.



(B) The shareholders adopted an amendment to the Articles of Incorporation changing the name of the Corporation to: MORTENSEN CENTER, INC.


