ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. <u>NAME</u>: The name of the corporation is THE COUNSELING CENTER, INC.

2. DURATION: The period of its duration is perpetual.

3. PROFIT: This is a profit corporation.

4. <u>PURPOSES</u>: The purpose or purposes for which the corporation is organized is to counsel under governmental agency grants needy and referred persons requiring help or assistance with alcoholic/drug related problems or any other form of counseling and for the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

5. <u>SHARES AUTHORIZED</u>: The aggregate number of shares which the corporation shall have authority to issue is FIVE HUNDRED (500) shares of no par value common stock.

6. <u>BUSINESS AFFAIRS</u>: Provisions for the regulation of the internal affiars of the corporation are such as may be provided by the corporation's By-laws, including restrictions on transfer of shares.
