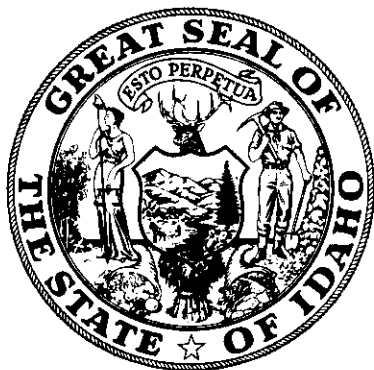

ARTICLES OF INCORPORATION

ARTICLE 1 NAME OF NONPROFIT CORPORATION:

The "WATER USERS ASSOCIATION OF PENNINGER FARM LATERAL-PENNINGER 11544 INC."

ARTICLE 2 TYPE OF CORPORATION:

The association is a nonprofit corporation.

ARTICLE 3 PERIOD OF DURATION:

The association shall be perpetual, unless the members of the association shall by majority vote elect to dissolve the association.

ARTICLE 4 THE PURPOSE FOR WHICH THE ASSOCIATION IS ORGANIZED AND INCORPORATED:

The association has been organized for the purpose of forming a lateral ditch water users' association under provisions of Idaho State Code 42-1301 thru 42-1309.

ARTICLE 5 NATURE OF THE ASSOCIATION:

The Association is made up of three or more home owners of the Hillcrest Subdivision taking water from the same lateral. Its affairs to be vested in its members and board of directors as organized under sections 30-314, and 42-1301 thru 42-1309 of the Idaho State Code.


