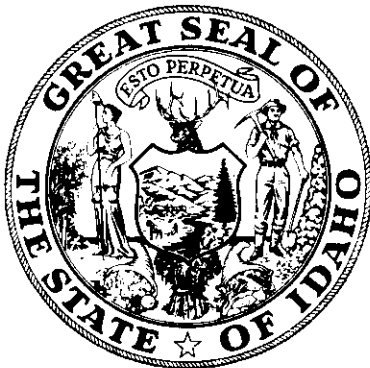

Pursuant to the provisions of 30-326 of the Idaho Non-profit Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is FRIENDS OF THE CHILDRENS SCHOOL INC.:

SECOND: The following amendment of the articles of incorporation was unanimously adopted by the board of directors of the corporation on February 9, 1984, in a manner prescribed by the Idaho Non-profit Corporation Act:

(a) Article III entitled Non-profit Corporation is hereby amended to add the following: This organization is not organized for profit, and no part of the earnings shall inure to the benefit of any private shareholder.

(b) Article VI entitled Purposes is hereby amended to add the following: (b) This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(c) Article VI entitled Purposes is hereby amended to add the following: (i) Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

(d) Article VI entitled Purposes is hereby amended to add the following: (j) This corporation will only fund programs which admit students of any race, color, and national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to its students and does not discriminate on the basis of race in administration of its educational policies, administrative policies, scholarship and loan programs, and athletic and other school administered programs.


AMENDMENTS TO ARTICLES OF INCORPORATION - 1.


THIRD: At the date of adoption of these amendments the corporation had no outstanding memberships.


