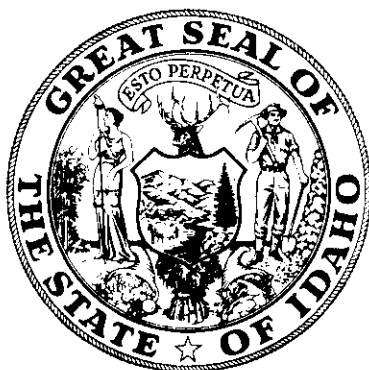

ARTICLES OF INCORPORATION

OF  
CREIGHTONS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Creightons, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, such shares to consist of one class only and shall have a par value of TEN DOLLARS (\$10.00) for each share.

The aggregate par value shall be \$100,000.00.

FIFTH: The address of the initial registered office of the corporation is 211 S. Main Street, Moscow, Idaho 83843, and the


