ARTICLES OF INCORPORATION

SHANNON FARMS, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby associate ourselves together with the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

I.

The name of the corporation shall be SHANNON FARMS, INC.

II.

The nature, objects and purposes for which this corporation is formed shall be:

- (a) To engage in a general livestoc, dairy and ranching business, both on its own account and as agent; to agist, feed, range, graze, manage, herd, control, brand, care for, purchase, market, and sell livestock of every kind, both on its own account and as agent for other persons or corporations; to buy, lease, cultivate, manage, operate, and sell farm properties and products therefrom both on its own account and as agent for other persons or corporations.
- (b) To breed, raise, import, export, and deal in cattle and livestock of all kinds, and to carry on a general cattle, dairy and grazing business, purchasing or acquiring, selling, or otherwise disposing of the stocks, supplies, equipment, accessories, appurtenances, products and by-products, of said business.
- (c) To engage in the business of buying, selling, distributing, leasing, servicing, repairing, and otherwise dealing in agriculture implements, vehicles, materials, machinery, and equipment, and in implements, vehicles, materials, machinery and equipment of allied lines.
- (d) To purchase, lease, or otherwise acquire agricultural lands and all matters connected with agricultural farming, including the purchase, sale, and other disposition of livestock, farm mathinery and all equipment and other property necessary or desirable in the operation of a farming operation.

- (e) To conduct and carry on the business of buying, selling, and dealing in all kinds of grain, hay, or other farm produce, and farm products, livestoc, and provisions, and all other kinds of goods, wares, and merchandise, and to do a general commission and brokerage business in any or all of the foregoing kinds of property.
- (f) To own, operate, and maintain a general wholesale and retail cattle and livestock business dealing primarily in the purchase and re-selling of cattle of all types and livestock of all types.
- (g) To buy, sell and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidence of debt, and the security for the payment of the same; to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of corporations, including this corporation.
- (h) To acquire by purchase, subscription or otherwise, and to hold and hypothecate, and to dispose of stocks, bonds, or other obligation of all kinds; and to sell, trade in and exchange the same, and all classes of stocks, bonds, notes, bills of sale and other securities.
- (i) To buy, hold, purchase, contract for, own, sell, mortgage, lease or exchange real or personal property of all kinds.
- (j) To carry into effect the objects and purposes aforesaid, this corporation is authorized to do all and singular the things necessary and convenient to carry out the general purposes for which it is organized.
- (k) All the foregoing provisions of this Article II are to be construed both as objects and powers, and it is hereby expressly provided that the enumeration herein of specific powers and objects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power to do any act which a corporation formed under the laws of the State of Idaho now or hereafter existing may not, at all times, lawfully carry on or do. It is the intention that the purpose, objects and powers specified in each of the paragraphs of this Article II shall, except as otherwise provided, in no wise be limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles contained or of any other provisions of these Articles of Incorporation.

The duration of this corporation shall be perpetual.
