## APPLICATION FOR NONPROFIT CORPORATION

STATE OF IDAHO

The undersigned, in order to form a nonprofit corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

ARTICLE 1. The name of the corporation shall be: Kinnikinnick Chapter of the Idaho Native Plant Society, Inc.

ARTICLE 2. The corporation is organized, and will be operated exclusively for educational and scientific purposes, within the meaning of Section (501)(c)(3) of the Internal Revenue Code, as related to native plants in the Idaho Panhandle.

ARTICLE 3. The street address of the registered agent is 365 Birch Haven Dr., Sagle, ID, and the registered agent is Bruce E. Vogelsinger.

ARTICLE 4. The board of directors shall consist of no fewer than three (3) people. The names and addresses of the initial directors are:

ARTICLE 7. The corporation will have voting members.


ARTICLE 8. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE 9. No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
