### ARTICLES OF INCORPORATION 91 NOV 27 AM 8 42

K & R, INC.

That we, the undersigned, KNOW ALL MEN BY THESE PRESENTS: acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for SECRETARY OF STATE such corporation:

#### FIRST

The name of the corporation is K & R, Inc.

#### SECOND

The period of its duration is perpetual.

#### THIRD

The purpose or purposes for which the corporation is organized is for the retail distribution of clothing; and to do such things incidental and necessary to the carrying on of such business together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-3 or any subsequent Idaho Statute relating thereto.
