ARTICLES OF INCORPORATION

THE RELIGIOUS FREEDOM COMMITTEE, INC.

OF

The undersigned, acting as Incorporators of THE RELIGIOUS FREEDOM COMMITTEE, INC., a nonprofit corporation organized under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such nonprofit corporation.

FIRST: The name of the nonprofit corporation is THE RELIGIOUS FREEDOM COMMITTEE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which nonprofit corporations may be incorporated under the Idaho Nonprofit Corporation Act.

FOURTH: This nonprofit corporation shall issue certificates indicating membership rights.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are: The Bylaws shall set the number of and qualifications of Directors and Officers.

SIXTH: This nonprofit corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

SEVENTH: Notwithstanding any other article of these provisions, this nonprofit corporation shall not carry on any other activity or activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code.

EIGHTH: The address of the initial registered office of the corporation is 3000 Esquire Drive, Boise, Idaho, 83704, and the name of its initial registered agent at such address is: Gene Crewse.

NINTH: The number of directors constituting the initial Board of Directors of this nonprofit corporation is three. The names and addresses of the persons who are to serve

ELEVENTH: The provision for the distribution of assets or dissolution or final liquidation are: Upon the dissolution of this nonprofit corporation, the Board of Directors shall, after paying or making provisions for payment of all the liabilities of the corporation, dispose of all of the assets of the corporation in such a manner or to such organization or organizations which are organized and operated exclusively for charitable, educational, religious or scientific purpose as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), as the board of directors shall determine. such assets not so disposed of shall be disposed of by the District Court for the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes and qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 or as may hereinafter be amended.
