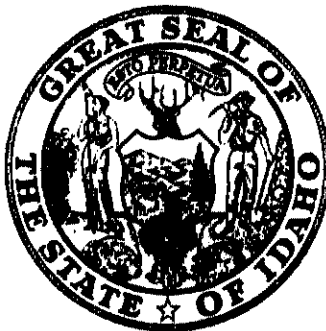
CERTIFICATE OF INCORPORATION OF
