


ARTICLES OF INCORPORATION

OF

TRINITY BAPTIST CHURCH

OF BOISE, IDAHO, INC.

THE REGISTERED OFFICE SHALL BE 1765 E Bergeson Ave Boise, idaho 83706



Be it known that we, the undersigned, all of whom are of full age and citizens of the United States of America, and residents of the State of Idaho, do voluntarily associate ourselves for the purpose of forming a religious corporation under the laws of the State of Idaho, and particularly under Chapter II of Title 30 of Idaho Code, and we do hereby make, subscribe and execute the following articles of Incorporation.

ARTICLE I

NAME

The name of this corporation is TRINITY BAPTIST CHURCH OF BOISE, IDAHO, INC.

ARTICLE II

PURPOSE

This is a non-profit Corporation, established for the purpose of proclaiming the Gospel of Jesus Christ publicly and privately, locally and around the world, to give its members and others an opportunity for worship, Biblical learning, and service. The duration of this corporation shall be perpetual. Upon the winding up and disolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which has established its tax exempt status under state and federal codes.

ARTICLE III

BOARD OF TRUSTEES

The operation of the affairs of this Corporation shall be vested in a Board of Trustees to consist of three or

more members, to be elected according to the constitution adopted by Trinity Baptist Church November 14, 1993. "The church shall elect three or more trustees to serve as legal officers for the church. They shall hold in trust the church property. Upon a specific vote of the church authorizing each action, they shall have the power to buy, sell, mortgage, lease, or transfer any church property. When the signatures of trustees are required, they shall sign legal documents involving the sale, mortgage, purchase, or rental of property, or other legal documents related to church approved matters. Trustees shall serve on a rotation basis, with one new trustee being elected every year.

Three trustees were elected, March 21, 1993. They are: Dwight Pike 3615 Sweetwater Drive, Boise, Idaho 83705; Jeff Russell, 6433 Kirkwood Road, Boise, Idaho 83709; and Bill Young, 12062 W Emerson Street, Boise, Idaho 83709. The following officers were elected: President and initial regestered agent, Gail L Graves, 1765 E Bergeson Street, Boise, Idaho 83706; Treasurer, Lori Young, 12062 W Emerson Street, Boise, Idaho 83709; Clerk, Joyce Graves, 3271 E Aubreitta Street, Boise, Idaho 83705.
