### ARTICLES OF AMENDMENT

TO

#### ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

I.

The name of the corporation is White, Ahrens, Peterson & Perry, P.A.

II.

The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on December 3, 1990, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article I be amended in its entirety to read as follows:

#### "ARTICLE I.

The name of the corporation shall be White, Peterson, Perry, Pruss, Morrow & Gigray, P.A."

RESOLVED FURTHER, that the remaining articles shall remain the same and not be amended in any way.
