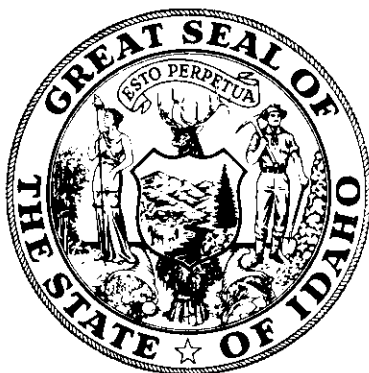

ARTICLES OF INCORPORATION OF

The undersigned, Chairman of the Board and Secretary of Moscow, Idaho Grace Bible Church, Inc., hereby certify that the following Amendment to the Articles of Incorporation of Moscow, Idaho Grace Bible Church, Inc., was duly approved by the Corporation, as follows:

FIRST: The name of the corporation is Moscow, Idaho Grace Bible Church, Inc.


SECOND: The amendment to the Articles of Incorporation is to amend the paragraph therein designated as "EIGHTH (d)", said amended provision to read in its entirety as follows:

EIGHTH (d): Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.


THIRD: The foregoing amendment was adopted at a special meeting of the members of Moscow, Idaho Grace Bible Church, Inc., held on the 16<sup>th</sup> day of January, 1987. That a quorum was present at such meeting and that such amendment received at least a majority of the votes which members present at such meeting in person or by proxy were entitled to cast.
