WE, THE UNDERSIGNED natural persons of the age of twenty-one years or more, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

#### ARTICLE I: NAME

The name of this Corporation is: NAYLOR INSURANCE, INC.

#### ARTICLE II: DURATION

The period of duration of this Corporation is perpetual.

#### ARTICLE III: PURPOSES

The purposes for which this Corporation is organized is to engage in the business of selling and servicing insurance; and doing all things and engaging in all lawful transactions which a corporation organized under the laws of the State of Idaho might do or engage in, even though not expressly stated herein.

#### ARTICLE IV: SHARES OF STOCK
