ARTICLES OF INCORPORATION

OF

**KNOW ALL MEN BY THESE PRESENTS: That we, the under-
signed, each being a natural person of full age and a citizen of
the United States, in order to form a corporation for the
purposes hereinafter stated, under and pursuant to the provisions
of the general corporation laws of the State of Idaho, and the
acts amendatory thereof, and supplemental thereto, do hereby
certify as follows:**

ARTICLE I

The name of the corporation is dBELL CONSULTANTS, INC.

ARTICLE II

**The objects and purposes for which this corporation is
formed are:**

**The transaction of any or all lawful business for which
corporations may be incorporated under the Idaho Business
Corporation Act.**

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

The location and address of the registered office of the corporation shall be, and is 3100 Springwood Drive, Meridian, Idaho 83642, and the name of its initial registered agent at such address is Dianna L. Stork.

ARTICLE V

The amount of the capital stock of the corporation shall be, and is divided into 5,000 shares. Each share shall have a stated par value of \$10.00. Said stock shall be, and is, nonassessable.

ARTICLE VI

ARTICLE VII

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation.

ARTICLE VIII

(a) The corporation shall not have a board of directors, but shall be run and managed directly by the shareholders.

(b) The incorporators set forth above are the only shareholders of the corporation.

ARTICLE IX

No contract or other transaction between the corporation and any other corporation and no act of the corporation shall in any way be affected or invalidated by the fact that any of the shareholders of the corporation is pecuniarily or otherwise interested in or is a director or officer of such other corporation; any shareholder or any firm of which any shareholder may be a member, may be a party to or may be pecuniarily interested in any contract or transaction of the corporation, provided the fact that he or such firm is so interest shall be disclosed or shall have been known to the shareholders or a majority thereof; and any shareholder of the corporation who is also a director or officer of such other corporation, or who is so interested may be counted in determining the existence of a quorum at any meeting of the corporation which shall authorize any such contract or transaction with like force and effect as if he were no such director or officer of such other corporation or not so interested.
