KNOW ALL MEN BY THESE PRESENTS that I, the undersigned, being of legal age and a citizen of the United States, on this day voluntarily form a corporation under the provisions of the Idaho Business Corporation Act and I hereby certify in writing the Articles of Incorporation, in writing as follows:

**ARTICLE I: NAME**

The name of the corporation shall be **ROCKY MOUNTAIN PLUMBING, INC.**

**ARTICLE II: PURPOSE AND POWERS**

The purposes for which this corporation is formed are to engage in any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act and to possess and exercise all of the powers and privileges granted by the Idaho Business Corporation Act or by any lawful powers and privileges incidental thereto so far as such powers and privileges are necessary or convenient to the conduct, promotion or attainment of the business or purpose of the corporation, including the conducting of a plumbing business which business includes the design, installation and repair of plumbing of all kinds and types for buildings, houses, offices and commercial enterprises, including the acquisition of plumbing tools and machinery of all types, the purchase and selling of plumbing, related plumbing supplies, installation of pipes and plumbing materials, the

purchase and operation of trucks, motor vehicles, tractors, backhoes and other mechanical devices related with the repair, installation and modification of plumbing, which business will be effectuated within the boundaries of the State of Idaho.

#### **ARTICLE III: DURATION**

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

#### **ARTICLE IV: REGISTERED OFFICE**

The registered office of said corporation in the State of Idaho shall be located at: 529 7th Avenue West, Jerome, Idaho 83338. Rick Allen Young shall be the Registered Agent at the address set forth above.

#### **ARTICLE V: CORPORATE STOCK**

The aggregate number of shares which the corporation shall be authorized to issue is 1,000 shares of stock, which has a no par value.

#### **ARTICLE VI: INCORPORATOR**

The following is the name and post office address of the incorporator:

#### **ARTICLE VII: MANAGEMENT**

The business of the corporation shall be managed by a board of directors of not to exceed three (3) in number. A director shall hold office for the term which he or she was named or elected until his or her successor is elected and qualified.

The initial board of directors shall consist of one person whose name is Rick Allen Young, and he shall serve as initial director until the first annual meeting of the shareholders or until his respective successor is elected and qualified.

**ARTICLE VIII: BYLAWS**

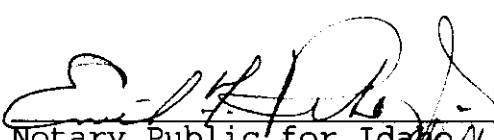
