Boise Cascade Corporation, a corporation organized and existing under the General Corporation Law of the State of Delaware (hereinafter called the "Corporation"), does hereby certify as follows:

(1) That the following amendments of the Certificate of Incorporation of the Corporation, as heretofore amended, have been duly adopted in accordance with the provisions of Section 242 of Title 8 of the Delaware Code:

Article Fourth of the Certificate of Incorporation of the Corporation is hereby amended in the following respects:

(a) The first paragraph is amended to read as follows:

"FOURTH: The total number of shares of all classes which the corporation shall have authority to issue is 1,736,800, of which 1,700,000 shares of the par value of Ten Dollars (\$10) each, amounting in the aggregate to \$17,000,000, shall be common stock (hereinafter referred to as "common shares"), and 36,800 shares of the par value of Fifty Dollars (\$50) each, amounting in the aggregate to \$1,840,000 shall be preferred stock (hereinafter referred to as "preferred shares")."

- (b) Subparagraph (f) is amended to read as follows:
- "(f) No holder of shares of any class of the corporation or holder of any security or obligation convertible into shares of any class of the corporation shall have any preemptive right whatever to subscribe for, purchase or otherwise acquire shares of the corporation of any class, heretofore or by this amendment authorized."

(2) That the capital of the corporation will not be reduced under or by reason of said amendment.
