Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, N. L. Terteling Family Interests, Inc., has adopted the following Articles of Amendment to its Articles of Incorporation:

The name of the corporation is N. L. Terteling Family Interests, Inc.

ΙI

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on april 27 , 1984, in the manner prescribed by the Idaho Business Corporation Act:

Article V of the Articles of Incorporation of the coproration is amended to read as follows:

v

The business of this corporation shall be managed and conducted by a board of directors. The number of directors shall be not more than five (5) nor less than three (3), except that if at any time there are less than three shareholders, there may be the same number of directors as shareholders. Treasury stock shall be disregarded in determining the number of shareholders of the corporation.

III

The number of shares of the corporation outstanding at the time of such adoption was 30, and the number of shares entitled to vote thereon was 30.

The number of shares voted for such amendment was 30, and the number of shares voted against such amendment was 0.

Such amendment does not effect a change in the stated capital of the corporation.
