## OAKLEY CANAL COMPANY

KNOW ALL MEN BY THESE PRESENTS, That a Special Peeting of the Stockholders of the Oakley Canal Company was had and held at the office of the said Company, at Oakley, in the County of Cassia, State of Idaho, on the 5th day of September, 1936, at the hour of two o'clock P.M., pursuant to a call of the Board of Directors, of said Company duly made at its regular meeting held on the 15th day of August, 1936, for the purpose of submitting to the Stockholders of said corporation the proposition of extending the corporate existence of said corporation for a period of fifty (50) years from and after the date of holding said meeting.

That Wm. J. Speckmon was Chairman and Wm. H. Martin was Secretary of the said meeting.

The roll call by shares, showed that there were 15,283.56 shares of stock represented, either in person or by proxy.

That at said meeting Edward Number as stockholder, of the said Corporation offered the following resolution, and moved its adoption, to-wit;

## RESCLUTION.

RESOLVED, That the corporate existence of the Oakley Canal Company shall be, and the same is hereby extended for a period of fifty (50) years from and after the 5th day of September, 1936.

That the Chairman and Secretary of this meeting and the Board of Directors of the Oakley Canal Company be, and they are hereby authorized to file in the office of the County Recorder of Cassia County, Idaho, the county in which the original Articles of Incorporation of the Oakley Canal. Company are filed, and in the office of the Secretary of State of the State of Idaho, a certificate of the proceedings of said meeting extending the corporate existence of said corporation for the period herein specified."

The motion was seconded by M.T. Woodhouse, a stockholder of the said Corporation. The question being shall the resolution be adopted? The stockholders representing 15,283.56 shares of stock voted for the adoption of the said resolution. That stockholders representing None shares of stock voted against the adoption of said resolution. There are now outstanding 20,901.97 shares of stock of said corporation; that more than two-thirds of the outstanding stock of said Corporation voted for the adoption of the said resolution, and the Chairman declared the resolution adopted.

That by reason of the adoption of the said Resolution, and the filing of this certificate, the corporate existence of the Oakley Canal Company is hereby extended for a period of fifty (50) years from and after the 5th day of September, 1936.
