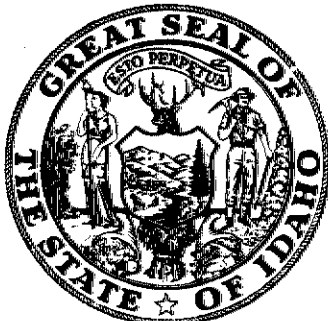

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Rowen Marketing, Inc.
(hereafter "Corporation").

ARTICLE II


ARTICLE VII
