Pursuant to Section 30-22-205 of the Idaho Model Entity Transactions Act (the "Act"), the undersigned limited liability company and limited partnership hereby adopt the following Statement of Merger:

1. The name, jurisdiction of formation, and type of entity of each merging entity that is not the surviving entity is:

Peterson Properties L.P., a limited partnership formed under the laws of the State of Idaho (the "Disappearing Entity").
2. The name, jurisdiction of formation, and type of entity of the surviving entity is:

Peterson Properties (McCall) LLC, a limited liability company formed under the laws of Washington (the "Surviving Entity").
3. The merger shall become effective upon the later of (i) the date on which Articles of Merger have been duly filed with the Secretary of State for the State of Washington, and (ii) the date on which this Statement of Merger has been duly filed with the Secretary of State for the State of Idaho.
4. The merger of the Disappearing Entity with and into the Surviving Entity was duly approved by all of the general and limited partners of the Disappearing Entity pursuant to Section 30-22-203 of the Act, and by all of the members of the Surviving Entity pursuant to RCW 25.15.421.
5. The title of an office or other position with the Surviving Entity, if service of process, notices, and demands are to be sent to whichever individual is holding that office or position, and the address to which process, notices or demands are to be sent are designated pursuant to 30-21-411 of the Act, to as follows:
