ARTICLES OF INCORPORATION OF OLD NORTHWEST AGENTS, INC.

The undersigned incorporator, being a natural person of full age, in order to form a corporation under Minnesota Statutes, Chapter 302A, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this Corporation is Old Northwest Agents,

ARTICLE II.

The registered office of this Corporation is located at 4901 West 77th Street, Edina, Minnesota 55435.

ARTICLE III.

- 3.01. The aggregate number of shares of stock which this Corporation shall have the authority to issue is 25,000 shares. The par value for each share of stock shall be one (1) cent per share.
- 3.02. The Board of Directors may, from time to time, establish by resolution different classes or series of shares and may fix the rights and preferences of said shares in any class or series.
- 3.03. The Board of Directors shall have the authority to issue shares of a class or series to holders of shares of

another class or series to effectuate share dividends, splits, or conversion of its outstanding shares.

- 3.04. No shareholder of the Corporation shall have any preemptive rights.
- 3.05. No shareholder shall be entitled to any cumulative voting rights.
- 3.06. The shareholders shall take action by the affirmative vote of the holders of over 50% of the voting power
 of all voting shares, except where a larger proportion is required
 by law, these Articles, or a shareholder control agreement.

ARTICLE IV.

An action required or permitted to be taken by the Board of Directors of this Corporation may be taken by written action signed by that number of directors that would be required to take the same action at a meeting of the Board at which all directors are present, except as to those matters requiring shareholder approval, in which case the written action must be signed by all members of the Board of Directors then in office.
