

ARTICLES OF INCORPORATION,
OF THE
ALPHA LATERAL COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned have this day, voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end we certify:

First:-

That the name of the said corporation is, The Alpha Lateral Company Limited.

Second:-

That the purposes for which the said corporation is formed are, to own, hold and acquire, by purchase or otherwise, irrigation or waste ditches or laterals, dams, reservoirs, regulating gates, flumes or viaducts and all other structures or devices that are necessary for the operation, and maintenance of said irrigation ditches or laterals, and to purchase or otherwise acquire, rights of way for irrigation ditches or laterals or waste channels, and to operate said ditches and laterals for the purpose of conveying and distributing such water as the shareholders may be entitled to receive from the canal of the Farmer's Co-operative Irrigation Company, Limited, to the lands belonging to, or elsewhere for the use and benefit of, the said shareholders, and to do and perform all such other acts and things as may be necessary or essential to the full and complete carrying out of the purposes herein indicated.

Third:-

That the place where its principal business is transacted shall be the town of New Plymouth, Canyon County, Idaho.

Fourth:-

That the term for which it is to exist is fifty years from and after the date of its incorporation.
