AMENDED ARTICLES OF INCORPORATION

STATE EXCHANGE ENTERPRISES OF IDAHO FALLS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, acting as President of Exchange Enterprises of Idaho Falls, Inc., met in a Special Meeting of the Shareholders on July 7th, 1980 which meeting was duly convened pursuant to the statutes of the State of Idaho.

At such meeting and pursuant to the Statutes of the State of Idaho, the following resolutions were enacted:

RESOLVED:

"That the Articles of Incorporation of Exchange Enterprises of Idaho Falls, Inc. be and hereby are changed and amended as follows:

ARTICLE I - NAME

The name of this corporation shall be:

EXCHANGE WORLD, INC.

All other provisions of said articles shall remain unchanged."

IT WAS FURTHER RESOLVED:

"That upon receipt of approval of the name change from the Secretary of State of Idaho, all outstanding stock of Exchange Enterprises of Idaho Falls, Inc. shall be surrendered and new stock from Exchange World, Inc. in like amounts shall be issued."

The number of shares now issued and outstanding is 5,000 shares of common stock, all shares being entitled to vote. Voting was unanimous for enaction of the amendment.
