## KNOW ALL MEN BY THESE PRESENTS:

THAT WE, THE UNDERSIGNED, natural persons of the age of twenty-one years or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation of said corporation pursuant to the Idaho Non-Proft Corporation Act.

Ι.

The name of the Corporation is:

THE NATIONAL HEMOPHILIA FOUNDATION, INC.

II.

The purposes for which this Corporation is formed are:

- (a) Assisting hemophiliacs in its territorial area in every way possible.
- (b) Encourage and assist in the treatment and medical care of those affected.
- (c) Encourage and promote research in hemophilia under the regulations of the National Hemophilia Foundation.
- (d) Aid in the education of parents and the general public in the problems of hemophilia.
- (e) To solicit, collect, or otherwise raise and receive money for the foregoing purposes and for other purposes directly applicable to the treatment of hemophilia and assistance to those affected with hemophilia.
- (f) To exercise all the powers conferred upon a corporation formed under the Idaho Non-Profit Corporation Act in order to accomplish its charitable purposes, including but not limited to the power to accept donations of money or property, whether real or personal, or any interest therein and wherever situated and, in general to do anything to advance the welfare of the corporation subject to such limitations that may be prescribed by law.

III.

The Corporation is to have perpetual existence.

That the Corporation is a Non-Profit Corporation and shall not possess or exercise any power or authority either expressly by interpretation or by operation of law that will prevent it at any time from qualifying and continuing to qualify as a Non-Profit Corporation as described in the Idaho Non-Profit Corporation Act, or as continuing to qualify as a Corporation described in Section 501 (c) of the Internal Revenue Code, 1954, as amended.

VI.

The Corporation shall issue no capital stock.

VII.

Except for the inital Board of Directors, whose names are set forth in these Articles of Incorporation, the Board of Directors shall be elected or appointed as provided in the By-Laws.

VIII.

Provisions for the regulation of the internal affairs of the Corporation, except as provided in these Articles of Incorporation, shall be determined and fixed by the By-Laws.

IX.

Upon termination, dissolution or winding up of the Corporation in any manner or for any reason, its assets, if any remaining after payment of all liabilities of the Corporation, shall be distributed to, and only to, one or more organizations having either exclusively charitable, scientific or educational purposes as described in Section 501 (c) of the Internal Revenue Code.
