ARTICLES OF INCORPORATION OF UNITED ENTERPRISES INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are of full age, and citizens of the United States of America, have this day voluntarily associated ourselves together, and do hereby, and by these Articles of Incorporation, unite and associate ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho, for the lawful purposes heremafter stated.

I.

The name of this Corporation shall be UNITED ENTERPRISES INC.

II.

The location and post office address of this Corporation shall be in the City of Pocatello, County of Bannock, State of Idaho at Box 4520.

III.

That this Corporation shall have perpetual existence.

IV.

That the purposes for which this Corporation is formed are generally to engage in the pursuit of all lawful activities and business as provided by the laws of the State of Idaho, and particularly:

(a) To engage in the business of warehousing, buying and selling land, obtaining dealerships and franchises, promoting and developing patent rights or potential patent rights, setting up farm machinery, repair shops and otherwise engage in lawful pursuits in conjunction but not exclusively, with farm co-operatives, credit unions and insurance general agencies.

- (b) To buy, sell, distribute and manufacture oil, grease, farm equipment and supplies, paint, building supplies shop equipment and other goods of any kind and nature.
- (c) To buy or hold, sell, and to lease, rent, occupy, and use all kinds and classes of real and personal property within and outside of the State of Idaho.
- (d) To mortgage, pledge, hypothecate, issue deeds of trust, or otherwise use, real and personal property as security for the purpose of borrowing money, obtaining credits, or dealing in real or personal property, and to make, execute and deliver and issue securities, stocks, bonds, debentures, mortgages, notes or other collaterals created or issued by this corporation or any corporation wherever organized in the United States or organized by the United States or any state thereof, and to buy, sell, negotiate or otherwise deal in securities, stocks, bonds, mortgages, notes, assignments, or other collaterals or securities issued by any state of the United States, or by any county, city, town, village, municipality, or district therein, or any political subdivision thereof, to the fullest extent permitted by the laws of the State of Idaho, and to exercise all rights, powers and privileges of ownership.
- (e) To incur indebtedness without limit, to borrow money, and to receive payment of money loaned in any manner consistent with the laws of the State of Idaho or of other states of the United States, and to issue its capital stock in payment for or exchange for cash, real and/or personal property, choses in action, or any other thing of value, including shares in any other corporation, firm, or association.
- (f) To enter into, make and perform contracts of every sort and kind with any person, association or corporation,

and to draw, make, accept, endorse, discount and execute promissory notes, bills of exchange and other instruments that are evidences of indebtedness.

- (g) To build, construct, erect, purchase and sell all types of buildings.
- (h) To engage in any and all types of manufacturing, assembling, and producing of products of all kinds including furniture, equipment, industrial and commercial machinery and attachments to other equipment and machinery and to engage in the production and sale of chemical products; to lease, rent, buy, own, sell and acquire any and all necessary machinery to the carrying out of these purposes and to employ and use all necessary aid and assistance including research and experimental equipment; to contract in any legal manner for the promotion of said aims and objects and to acquire other corporations or their assets and to assume such corporations liabilities all in the promotion of the objectives mentione $\vec{\boldsymbol{a}}$ herein and to do so with cash, shares in this corporation or shares in other corporations owned by this corporation and in general to manufacture, develop, promote and sell products of the corporation produced under this purpose.
- (i) To engage in the warehousing business under the laws of Idaho and to take advantage of any and all laws of said state with respect to distribution of inventory and products acquired for re-shipment and to issue and deliver any and all necessary documents to carry out this purpose.
- (j) To own patents or licenses to manufacture, produce, promote and sell, any products or items of personal property whatseever so long as the same may be done by lawful means and to issue limited or unlimited franchises to other persons, firms,

or corporations and to receive cash, shares of stock, royalties or any other things of value in exchange therefore whether the same be tangibles or intangibles and/or real or personal property.

- (k) To own shares in and to vote same and control or manage other corporations either profit or non-profit and particularly to organize or cause to be organized, and manage a non-profit agricultural association cooperative, insurance banking, commercial, manufacturing, producing and sales corporations as subsidiaries of this corporation at which times or in which places as may be in the sole judgment of the Directors for the best interests and welfare of this corporation but this power may be exercised only where and when the exercise thereof is legal and lawful under the laws of the United States, Idaho, all other States and territories and/or possessions of the United States and any foreign countries.
- (1) To promote, establish, operate and conduct any other lawful business which is within the purposes and powers of the corporation or which may be incidental to the exercise of any such powers or which may be necessary to protect, preserve and enhance the value of the corporation's franchises, property and business, and to pay all taxes, state, federal, municipal or other.

٧.

The capital stock of this corporation shall be TWO HUNDRED FIFTY THOUSAND (\$250,000.00) DOLLARS divided into One Million Shares (1,000,000) all of one class namely, common, non-assessable, each share to have a par value of Twenty-five (\$.25) Cents.

VI.

The business, corporate powers and authority of the corporation shall be exercised, conducted and controlled by a

Board of Directors consisting of not less than three (3) nor more than fifteen (15) who shall be owners of at least one share of the common stock of this corporation. The Board of Directors shall have the power to repeal, amend and adopt new By-Laws of and for the company and to hold regular meetings in accordance with the By-Laws and at such times and places as the Directors may fix both within and outside of the State of Idaho.

That the first Board of Directors is fixed at three (3) and shall hold office for one year from the date hereof, and until their successors are elected and qualified, and their names and post office addresses are as follows:
