ARTICLES OF INCORPORATION

OF

COMMUNITY CHRISTIAN SCHOOL, INC.

We, the undersigned residents of the State of Idaho, being twenty one years or more of age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

ARTICLE I.

The name of the corporation shall be COMMUNITY CHRISTIAN SCHOOL, INC., and its location shall be 110 West Jackson, City of Bonners Ferry, County of Boundary, State of Idaho.

ARTICLE II.

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE III.

The business and purpose for which this corporation is organized shall be exclusivly for educational non-profit school purposes relating to the instruction or training of the individual to improve or develope his or her capabilities.

ARTICLE IV.

Management of the Corporation shall be vested in the Board of Directors subject to limitations as set forth in these Articles and in the By-laws of the

corporation.

ARTICLE V.

The business of the Corporation shall be managed and conducted by a Board of Directors of not less than three (3) Directors. The Board of Directors shall be elected in the manner set forth in the By-Laws.

In addition to the powers and authority granted to the Directors in these Articles of Incorporation, and in addition to the powers and authority expressly conferred on them by statute, the Board of Directors of the Corporation shall have such additional powers and authority, not inconsistent with law, as may be set forth in the By-Laws.

ARTICLE VI.

The corporation reserves the right to amend, add to, or repeal any provision contained in these Articles of Incorporation, in the manner consistent with law and in conformity with the provisions set forth by the By-Laws.

ARTICLE VII.

In furtherance and not in limitation of the powers conferred by the laws of the State of Idaho, the Board of Directors is expressly authorized to frame and adopt any such By-Laws for the corporation as are not inconsistent with the laws of the State of Idaho and these Articles of Incorporation. Any By-Laws so adopted by the Board of Directors may be amended or repealed by vote of a majority of the corporation's membership at any regular meeting or at any special meeting

called for that purpose.

ARTICLE VIII.

The address of the initial registered office of the Corporation is 110 West Jackson, Bonners Ferry, Idaho 83805, and the name of its initial registered agent at such address is Chris Clark.

ARTICLE IX.

The number of directors constituting the initial Board of Directors of the Corporation is three, and the names and address of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify:

ARTICLE XI.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code, as the Board of Directors shall determine.
