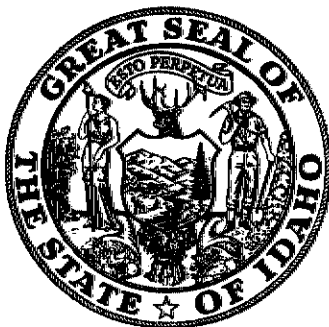

ARTICLE A

The name of this corporation is Indian Hills Ranch Inc.

ARTICLE B

The duration of this corporation shall be perpetual, or until legally dissolved in conformity with all applicable Idaho statutes.

ARTICLE C

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the Idaho Business Corporation Act other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by Idaho corporate law.

ARTICLE D
