

ARTICLES OF INCORPORATION

OF

GREG SELLERS ENTERPRISES, INC.

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Greg Sellers Enterprises, Inc.

ARTICLE II

The purposes for which said corporation is formed are:

A. To own, operate, conduct, franchise, sub-franchise, lease, purchase, sell or otherwise deal with diet centers, diet control programs, and related foods, products, supplements, nutritional aids, literature, equipment and fixtures of every name, nature and description.

B. To own, operate, and conduct a potato seed sales and brokerage business.

C. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be Route # 4, Box 208, Rexburg, County of Madison, State of Idaho and the name of its initial registered agent at such address is Gregory Dee Sellers.
