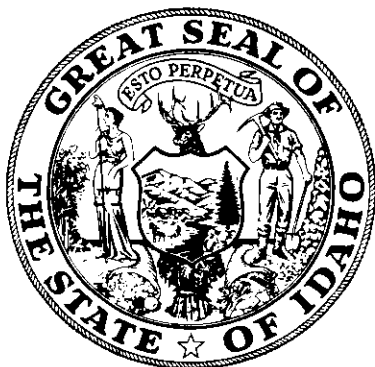

ARTICLES OF INCORPORATION  
OF  
SOLAR-AIRE OF BOISE, INC.

The undersigned, acting as incorporator(s) of a corporation under the Idaho Business Corporation Act, adopt(s) the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is SOLAR-AIRE OF BOISE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is TEN THOUSAND SHARES with a par value of \$1.00 per share.

FIFTH: Provisions denying preemptive rights are: NONE.

SIXTH: The shares of the Corporation shall be subject to restrictions on transfer contained in the By-Laws of the Corporation.

SEVENTH: The address of the initial registered office of the corporation is 5264 Chinden Boulevard, Boise, Idaho, and the name of its initial registered agent at such address is IRVIN M. NEWBY.




