

DESIGNATION OF AGENT AND ACCEPTANCE OF THE PROVISIONS OF THE
CONSTITUTION OF THE STATE OF IDAHO

KNOW ALL MEN BY THESE PRESENTS:

That INDUSTRIAL X-RAY INCORPORATED
a Corporation organized and existing under the laws of the State of WASHINGTON
having filed in the office of the Secretary of State of the State of Idaho a duly authenticated copy of its

accept the provisions of the Constitution of the State of Idaho for all the intents and purposes contem-
plated by the provisions thereof, relating to such acceptance by other than municipal corporations.
