The Undersigned, in order to form a Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation:

Article I: NAME

The name of this organization shall be the Community Intercultural Center, Inc.

Article II: PURPOSE

The purposes for which the corporation is organized and will be operated are as follow: Charitable, religious, educational, or scientific within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions of organizations that qualify as exempt under 501 (c) (3).

The goals of the Community Intercultural Center are to provide:

- a) English instruction for refugees and immigrants
- b) Advocacy, training, support services and activities to promote integration into the community for refugees and immigrants
- c) Education, information resources and services to promote cultural awareness and sensitivity within and of the community

Article III: REGISTERED OFFICE

The Street Address of the registered office of the corporation is in Ada County, Idaho. The address of the initial registered office is 2521 West Stewart Avenue, Boise, Idaho, 83702, and the name of the initial registered agent at this address is Theresa Baird.

Article IV: BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by its Board of Directors. The actual number of Board members shall not be less than three (3), but may be expanded as provided in the Bylaws of the Corporation. The names and address of the persons constituting the initial Board of Directors are:
